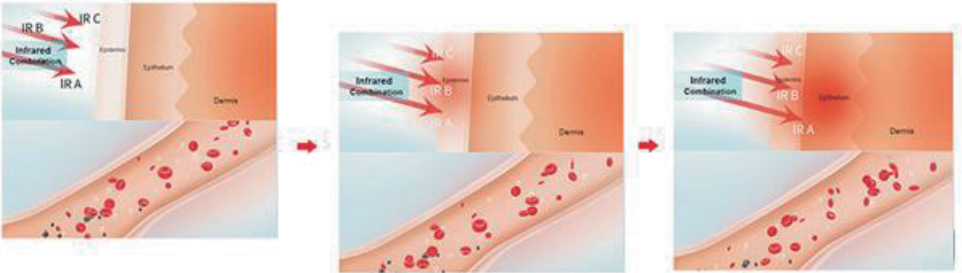

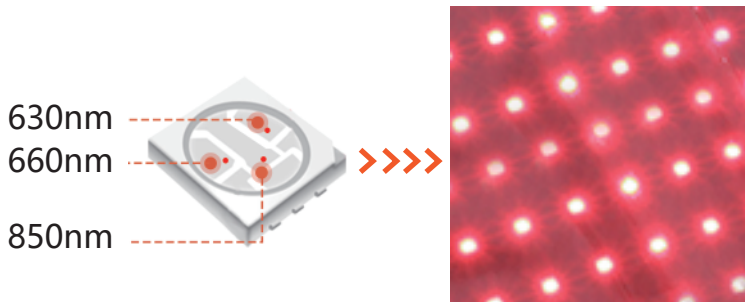
NEAR INFRARED – INFRARED A (IR A) Usually use 660nm–850nm

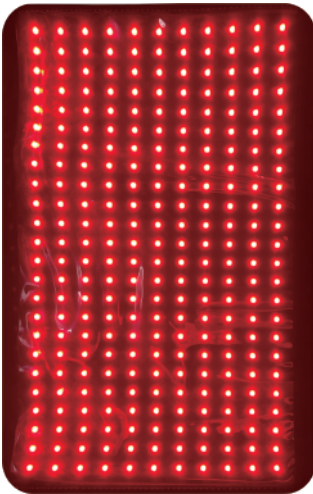

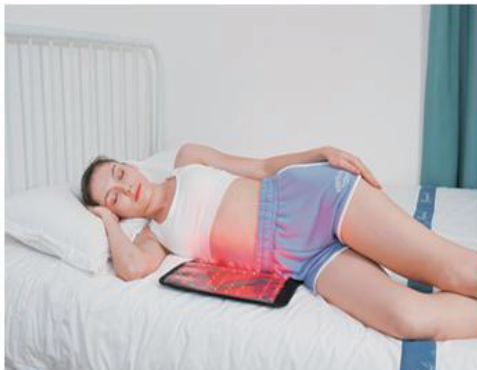
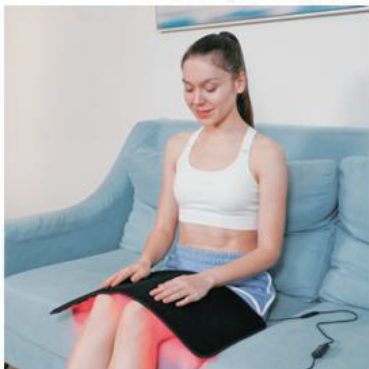
